

A regular meeting of the Session of First United Presbyterian Church of Elmwood was held in the Fellowship Hall on September 11, 2025. The meeting was opened with prayer and a moment of silence in remembrance of the September 11, 2001 terrorist attacks.

Elders present: 2025 - Anita Asbell and Steve Winslow

2026 - Ron Cox and Marty Tarter

constituting a quorum. Absent was Calie Stalter and Brandy Stevens. Rev. Maria Bauler moderated the meeting. The guidelines for a quorum were established at the January 9, 2025 Session Meeting as the presence of 50% of currently serving Elders.

Elder Training: Larry Criswell on the topic of the discipline of Service.

A motion was made to give voice to Emily Roberts who joined the meeting in order to talk about our financial standing.

The meeting agenda was reviewed and approved and will include ratifying the text message request to the Elders from Pastor Marla to allow Rev. Tim Bauler to preach on September 14, 2025.

Clerk's Report

The minutes from the August 14, 2025 Session Meeting were reviewed and approved. New correspondence from Great Rivers thanking us for paying our Per Capita and explaining how the funds are distributed.

Treasurer's Report

The Treasurer's Report for August 2025 was reviewed. Approved.

Pastor's Report

Pastor Marla gave a formal report which listed her monthly ministry activities. She was very busy with the Ministerium meetings, COM, PGR Assembly (along with our Presbytery Commissioner Marty Tarter) as well as walking in the Elmwood Fall Festival Parade.

Communion was served to 27 members of the congregation on September 7, 2025.

Committee Reports

Personnel: Chair - Ron Cox

Ron is very happy with all of our employees.

Finance: Co-Chairs - Larry Criswell & Marty Tarter

Emily Roberts, Treasurer, led a lengthy discussion regarding the declining financial situation of our church. When the Operations funds were low in the summer, we had to borrow \$5000 each from the Missions Checking and Savings accounts. It should be noted that our giving units have gone from 38 to 18 the past several years. (Possible 8 additional as some give cash making it difficult to track.) The Treasurer has requested permission to take \$10,000 per quarter from the investment fund (formerly known as Harrington Fund) – if necessary – to help pay our monthly bills. After much discussion, a motion was made by the Finance Committee to give such permission. Seconded. Approved.

A motion was made to discontinue withholding 11% from the Farm income and any offering or other income received. This change is to be effective October 1, 2025. Motion seconded and approved.

Please NOTE the 80% of the dividends from the Jonah Fund will continue to fund Missions.

A motion was made to close the Missions Savings Account effective October 1, 2025. Motion Seconded and Approved

Worship/Membership/Christian Ed: Co-Chairs -Anita Asbell & Calie Stalter

Worship: No report.

Christian Ed: Adult Sunday School continue their studies. Children's Sunday School is on summer break. Adult Sunday School reports the following financial accounting:

Church Work Day is scheduled for November 8, 2025. Will be looking into hiring someone to repair, update and take care of all landscaping maintenance.
